## **New Collegiate Scholarship Established**

Federally Employed Women (FEW) announces the availability of a new Scholarship program. During the National Board of Directors meeting held in Philadelphia, Pennsylvania, the National Board voted unanimously to establish a Collegiate Scholarship for FEW members. To qualify for this Scholarship, you must meet the following criteria: Be an active member of FEW for three years or more; be pursuing your first Associate Degree or first Bachelors Degree at an accredited institution; be a GS-10 or below (or equivalent in alternative pay systems); submit a two page essay addressing, "Why I Should be Awarded a FEW Collegiate Scholarship"; and submit three letters of reference, preferably from a Chapter President, Regional Manager, Community Leader and/or Supervisor. This Scholarship is established to assist highly motivated and academically talented members of FEW including actively employed members, members-at-large and retired members. The person receiving this scholarship is not limited to a particular field of study or career objective in pursing her or his academic discipline.
